Cette bibliographie thématique est destinée à accompagner le colloque international [L'enfant et ses proches. Dynamiques familiales en Afrique Subsaharienne](#) organisé le 26 au 28 octobre 2016 à l'Ined, Paris.

Sans prétendre à l'exhaustivité, elle couvre les questions étudiées par l'équipe du [projet ANR DyPE \(Dynamiques de parentalité et de l'enfance en milieu rural africain\)](#) et reprend les axes thématiques abordés pendant le colloque, structurée en 7 parties. Elle est basée sur une base bibliographique collaborative, établi par Elsa El-Hachem Kirby, ainsi que sur une recherche dans les principales bases de données bibliographiques et catalogues en sciences sociales et démographie ; elle se focalise sur la littérature récente depuis 2000. La bibliographie complète est également partagée en ligne sous un groupe [Zotero](#).

Presentation

This bibliography has been prepared for the purpose of the international conference 'Children and family dynamics in sub-Saharan Africa', held at INED, Paris from 26th to 28th October 2016.

Despite its coverage is not exhaustive, it includes the main topics studied by the research team of the [ANR project DyPE](#) : the bibliography is structured in 7 sections, in line with the thematic sessions of the conference. It is based on collaborative bibliographical database, established by Elsa El-Hachem Kirby, as well as a search in the main bibliographic data bases and library catalogs in the field of social sciences and demography. It puts a focus on the recent scholarly literature since 2000. The complete bibliography is also shared by means of a [Zotero group library](#).
